Actions In Progress

Reduce use of printed marketing materials

Target Completion Date: 31/12/2025

Objective

To reduce the overall use of paper

Target

Record baseline in year 2024 Reduce paper use by 20% in 2025

Action, Improvement or Control

Implement paperless office practices Develop a digital marketing pack for customers

Business Mileage emission reduction

Target Completion Date: 31/12/2030

Objective

Reduce emissions by switching away from diesel powered vehicles

Target

Employees receiving a car allowance to be encouraged to switch to hybrid/electric car within 5 years

Action, Improvement or Control

Incentivise switch through regular review of car allowance to allow purchase of Electric Vehicle

Carbon Offsetting

Target Completion Date: 31/12/2030

Objective

Continuous business functioning is likely to mean that 100% carbon emissions reduction is unrealistic. However, to offset any remaining carbon emissions generated by the organisation we commit to investigate and invest in carbon offsetting programmes.

Target

To offset any total remaining carbon emissions we are unable to offset by our own reduction actions

Action, Improvement or Control

To investigate and purchase independently verified carbon credits via certified carbon offset providers

Transportation - Receiving and delivery of goods

Target Completion Date: 31/12/2030

Objective

Use the lowest impact transport method available

Target

Only use delivery companies who have a CRP in place

Action, Improvement or Control

To request environmental policies from delivery companies used. Transport majority of goods via DHL while they continue to have a robust CRP in place. More electric vehicles being added to their fleet
